  - > Purchase or use of 1,000 or more tons of Hot Mix Asphalt must include a Pay Item for an Asphalt Price Adjustment reflecting changes in the cost of Asphalt Cement
  - A contracting unit applying a charge to those bidders submitting an Equivalent to the Brand Name in the phrase "Brand Name or Equivalent" - Meaning of the terms "Properly Executed Invoice" and "Unless Otherwise Provided for in the Contract..." in new Prompt Payment Law for Goods and Services
  - Handling by a local contracting unit of a declared "National Day of Mourning" when bids are scheduled to be received on that day
  - Some do not agree that the inclusion of the Mandatory Items in N.J.S.A. 40A:11-23.2 is the equivalent of a Finding of Materiality. Just because the statute states it's a Mandatory Item, that does not make it Material as a Matter of Law (Criteria of Materiality)
  - Do you allow those in attendance to review the Bids or Proposals once they are opened?
  - Maintenance of a Bidders' List, and notifying potential bidders in order to receive Addenda
  - Is a "Clarification" an "Addenda or Other Notice" requiring acknowledgement?\
  - The Local Public Contracts Law "Mail Bag" Issues
